This year N-C spent \$509,972 in the education fund compared to \$470,838 spent in the education fund last year. In the operation and maintenance fund, N-C spent \$84,676 this year compared to last year the district had spent \$316,183. The district spent \$80,410 in the transportation fund compared to \$78,523 last year. The district spent \$675,058 this year compared to \$865,544 last year at this time in those three funds for a difference of \$190,486 less this year compared to last year.

The 30th of September completed 25% of the 2016 fiscal year. The district expended 20.1% of the education budget, 13.7% of the operations and maintenance budget, and 30.7% of the transportation budget.

Fund balances as of September 30, 2016: Education: \$1,256,484, Building: \$471,601, Transportation: \$271,664, and Working Cash: \$142,714. The four Major Fund Balances: \$2,142,463. Total Fund Balance for all funds: \$3,199,851.

Fund balances as of September 30, 2015: Education: \$1,220,794, Building: \$398,191, Transportation: \$260,788 and Working Cash: \$113,379. The four Major Fund Balances: \$1,993,152. Total Fund Balance for all funds: \$2,976,484.

The district has \$149,331 more this year compare to last year in the four major funds. The district has \$223,367 more this year compared to last year in total fund balance.

Mrs. Miller informed the board that people have expressed interest in establishing a memorial at the school for Linda Henriksen. The board expressed their support.

# 7.0 Superintendent's Report

7.01 Consider the First Reading of the Updated Policies- Policy Committee

Mrs. Snyder has reviewed the updates and she does not feel we should approve all of the changes. Most of the policies are fine but she would like to review a few of them. She encouraged everyone to read the policies and it will be discussed at next month's meeting.

#### 7.03 Consider a Report on Transportation

Mr. Young shared that he was thankful for the assistance he had received from staff members during the difficult time of Linda Henriksen's death. He shared that at a recent Hancock County Superintendent's meeting, it was decided to put an advertisement for bus drivers in the newspaper. Every district needs bus drivers so this would be a good way to reach a larger audience. A training class is being planned for the area. Some classes are more than three hours away if you want to become a bus driver. They are contacting a doctor to possibly complete the drivers' physical after the training. This will hopefully make it easier to obtain a bus license.

We currently have two bus drop off areas in Nauvoo and have several in Niota and Colusa. We are looking at having two to three drop off points in Niota and Colusa. This will hopefully speed up the routes and get students in these areas home quicker.

We also want to lease one or two white buses. They cannot be used for routes, but they can be used to take students on activities and field trips. The driver does not need a bus license to drive a white bus. Mr. Young is supposed to get a quote for a white bus the week of the 17<sup>th</sup>. He will also get information on a minivan that could be used to transport students to and from school in Macomb and Colchester.
